Minutes of the previous meeting of the finance committee members held on 8<sup>th</sup> July 2022 were circulated prior to the meeting. The minutes were discussed and approved.

The Principal presented the tentative budget for the year 2023-2024. The budget was formulated with the deficit of the previous year factored in. The pandemic period was particularly challenging. The proposed budget copies were mailed in advance. The members had reviewed the details of the budget. All the members found the budget satisfactory. It was duly approved.

The financial status of the account books for the last two financial years were systematically reviewed by the members of the financial committee. Since there are no NOCs being received from the government and many senior lecturers are superannuated during the pandemic period the management has to pay a huge amount as salaries for teaching and non-teaching staff on management pay role. It was also noted that the 7<sup>th</sup> pay scales are implemented for aided staff on aided posts; Dr Kamthekar suggested the review and market correction for the salaries paid to the staff on management roll.

The Principal Dr Anagha Tendulkar Patil thanked the management for all the support and financial help rendered to college during the lockdown period. She also noted that the reopening of campus has proved to be quite demanding in terms of money, time and human resource.
