Madam / Sir,

With reference to the subject above, I am directed by the Hon'ble Pro-Vice-Chancellor to inform you that the report of the Local Inquiry Committee for **Extension of Recognition** for the **Ph.D.(Science & Technology)** degree course in the subject of **Microbiology** was placed before the Board of Deans at its meeting held on **21st January 2019**, vide item No.12, when it was resolved as under :-

"...be granted Extension of Recognition to enroll 08 students for Ph.D. (Science & Technology) Degree in the subject of Microbiology from the Academic Year 2018-19 to 2022-23, subject of yearly review of compliance of conditions stipulated by the LIC & recovery of dues towards recognition fees, if any...."

Pursuant to the above resolution of the Board of Deans, I am to inform you that the College/Institute has been granted permission for **Extension of Recognition** to enroll (08) eight students for the **Ph.D.(Science & Technology)** degree course in the subject of **Microbiology** for a period of five years from the Academic Year 2018-19 to 2022-23.

The Local Inquiry Committee in its report recommended the following conditions :-

- 1) Funds for Research Activity should be earmarked annually.
- 2) Separate infrastructure to be allocated exclusively for research.

You are therefore requested to comply with the aforesaid conditions recommended by the Local Inquiry Committee and submit your report in the matter, at the earliest, failing which the matter will be reported to University Authorities.

You are therefore, requested to pay the remaining fees of Rs.40,000/- (Rupees Forty Thousand Only), towards the Continuation of Recognition from the academic year 2019-20 to 2022-23, within 15 days, as a precondition for approval of extension of recognition.

Further, you are also requested to submit the proposal for continuation of recognition for the academic year 2023-24 onwards, on or before 30th September, 2022.
