

## **Workshop on Revised PBAS form and API calculations under CAS and on MOOCS**

Internal Quality Assurance Cell (IQAC) of Sophia College (Autonomous) organized a workshop on Revised PBAS form and API Calculations under CAS (after the 4<sup>th</sup> amendment) and on MOOCs on Friday 25<sup>th</sup> January 2019 for degree College teachers. IQAC sub-committee that collaboratively worked with Mrs. Sheila Master (IQAC committee) for the completion of this workshop consisted of the following staff members:

The poster and the registration form were made in advance and sent to different colleges by Dr (Sr.) Ananda Amritmahal and the committee members. Many participants registered in advance with few on the spot registrations.

The workshop was attended by various teachers in and outside Mumbai. There were 32 outside teacher participants and 25 in-house teachers making the total number of registrations to 57.

The resource persons were Mr. Sunil Mantri, Director (professional, Higher and Technical Education) and Mr. Abhishek Kumar Scientist C (CS), INFLIBNET.

The venue for the workshop was the Convention Centre. Registrations began at 8:30 am followed by inauguration and lighting of the lamp by Dr. (Sr.) Ananda Amritmahal and dignitaries. One of the committee members Dr. T.C.Roymon launched his book titled 'A Companion Guide to Western Philosophy (From Greeks to the Scholastics)'. The participants were given an opportunity to introduce themselves.

The first session was by Mr. Sunil Mantri on Revised PBAS form and API Calculations under CAS (after the 4<sup>th</sup> amendment). Mr. Mantri explained the amendments in the CAS and the revised PBAS form. He gave a detailed comparison of the previous rules and API calculations and the new ones which have been implemented after the 4<sup>th</sup> amendment. He discussed the activities and calculations for the same for all the categories i.e. I (Teaching Learning and Evaluation), II (Co-curricular and extension activities) and III (Research). Participants actively participated by asking their questions. Mr. Mantri addressed their queries in a convincing manner. He also shared all the circulars and forms with the participants. The material was sent to the participants through mail during the workshop.

The above session was followed by second session by Mr. Abhishek Kumar on MOOCs (development of e-learning material). Mr. Abhishek emphasized on need for e-learning and ICT based learning over and above the traditional and conventional methods. His session was mainly on "How to develop MOOCs?" He discussed the following under development of MOOCs

- ✓ Development of e-text



- ✓ Guidelines for recording of videos
- ✓ Guidelines to avoid plagiarism
- ✓ Guidelines for uploading the content to SWAYAM portal.

He also spoke about the API scores for the development of e-learning material/process under CAS. Participants who were SWAYAM co-coordinators of their respective colleges asked questions with regard to execution of the above. Mr. Abhishek Kumar addressed their queries and gave them more ideas. He also shared the circulars and the workshop material with the participants. The material was sent to the participants after the workshop via mail.

Ms. Tanaz Asha gave the vote of thanks.

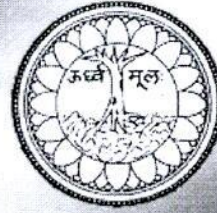
The participants gathered in the central lawn for lunch. They were given their certificates after the lunch.
