





- He/she will work for 3 years on the respective committee. On the expiry of term of nominee, institution/ organizations are required to reconstitute its IBSC in prescribed proforma.
- The DBT, on the expiry of the term of its nominee shall re-nominate or appoint a new nominee, and such nomination 5. shall be communicated to the institutes/ organizations.
- Any special invitee/s to IBSC should be communicated to RCGM/ or taken prior approval. 6.
- The IBSC of the institution will meet at least twice in a year.
