- The sea shoreline cleanliness shall be carried out during the low tide timings only.
- All the Volunteers shall display their photo IDs while carrying out beach cleaning.
- 4. This office will not be responsible for any type of theft/ damages to the belongings of the Volunteers during the beach cleaning activity in process.
- 5. The personal safety of the Volunteers will be the sole responsibility of the concerned Office requesting the permission to participate the beach cleaning activity.
